EXHIBITOR SPACE PLACEMENT

Final placement is at the discretion of The Body, Mind & Spirit Show. All exhibits must conform to requirements of The Body, Mind & Spirit Show and local fire department. All aisles must be kept clear within the boundaries set up by local fire codes.

SET UP & TAKE DOWN

Set up of exhibitor space must be completed 15 minutes prior to start time. The Body, Mind & Spirit Show reserves the right to re-allocate exhibit space not occupied within 30 minutes prior to the show. Dismantling of exhibit space before 5 PM is not permitted without consent from The Body, Mind & Spirit Show.

TRANSFER OF SPACE

Space is for use solely by the contracted exhibitor and may not be subleased to any other individual or business. Literature for a non-paying exhibitor may not be distributed, nor any other form of display allowed.

Failure to comply with any of the above terms & conditions may result in any or all of the following: a) expulsion from The Body, Mind & Spirit Show b) prohibition from participating in future shows c) forfeiture of the money paid by the exhibitor to The Body, Mind & Spirit Show.

The Body, Mind & Spirit Show does not guarantee specific volumes or levels of attendance. In the event it becomes necessary for The Body, Mind & Spirit Show or the Centro Caboto Centre to institute legal action for any claim arising out of the terms and conditions of this contract the losing of those proceedings shall pay all attorney fees and court costs incurred in connection with said proceedings.
